

# A CHANCE FOR KIDS & FAMILIES® PROMOTION 2019 · OFFICIAL RULES

NO PURCHASE OR CONTRIBUTION NECESSARY TO PARTICIPATE. A PURCHASE OR CONTRIBUTION WILL NOT INCREASE YOUR CHANCES OF WINNING.

**1. ELIGIBILITY:** The “A Chance for Kids & Families”® Promotion (the “Promotion”) will take place in participating stores in the following states (the “Territory”): BURGER KING® restaurants in MA, RI, NH, VT, ME, CT, NY, and NJ; and VALVOLINE INSTANT OIL CHANGE™ stores in MA, NH, and RI.
